

## HES Parent Survey Results January, 2016

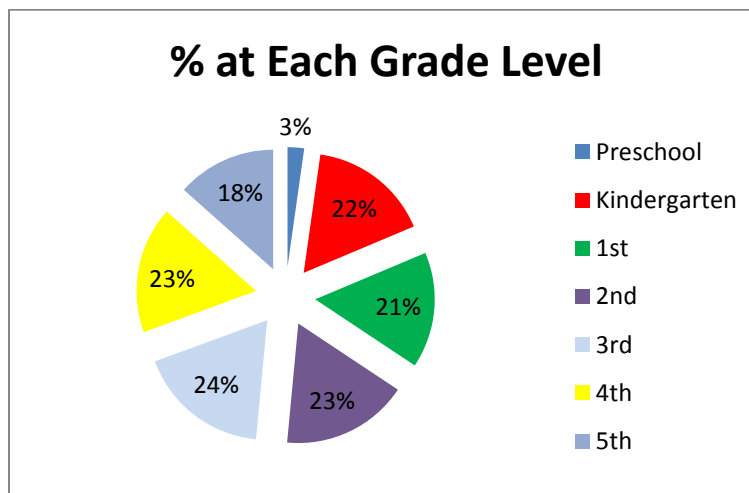
The Hildreth Elementary School (HES) School Council created a parent survey that was sent to parents in January, 2016. The survey window was open for two weeks, and parents were notified via email, website, and Twitter. There was a reminder email sent several days before the close of the survey. 239 people responded to the survey. HES currently has 440 children enrolled in the school. We appreciate the time people took to provide us with this feedback.

The School Council and faculty will review the survey data, and we will use the information to inform our School Improvement Plan. While the survey is overwhelmingly positive, it does provide opportunities for growth. We want to use this feedback to celebrate what we are doing well and reflect on and make changes to the areas of improvement. By partnering together, we can continue make HES the best school it can possible be.

This document provides the survey results for each question. For the three open-ended questions, we have provided information on the common themes to the responses. Also, include in this report are plans for “next steps.”

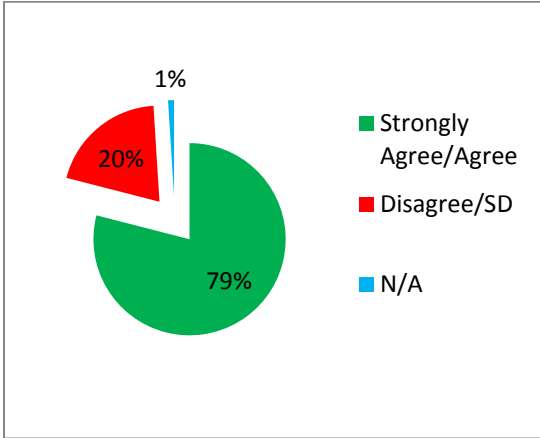
### 1. My child/children is/are in the following grades.

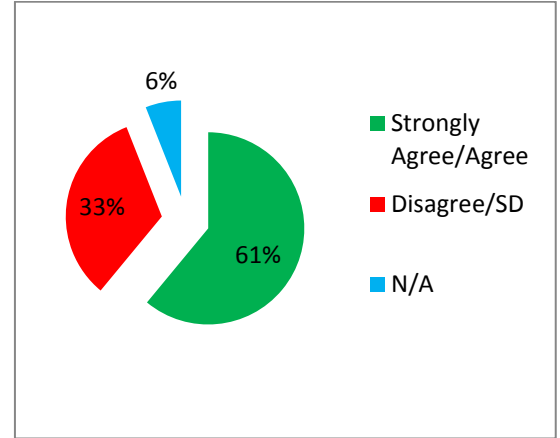


## 2. Please respond to the following statements about the atmosphere at our school.

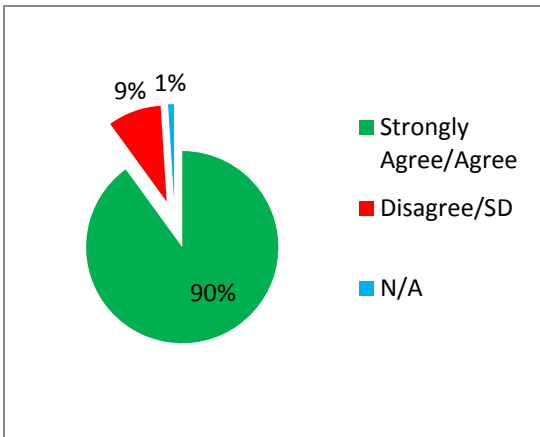
There are enough opportunities for parents to participate in the school community.



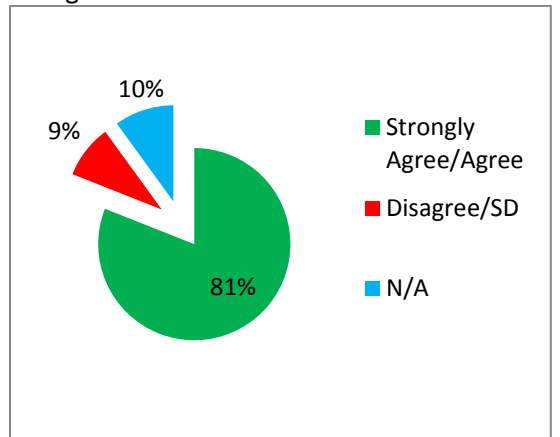
These opportunities are flexible enough to meet my scheduling needs.



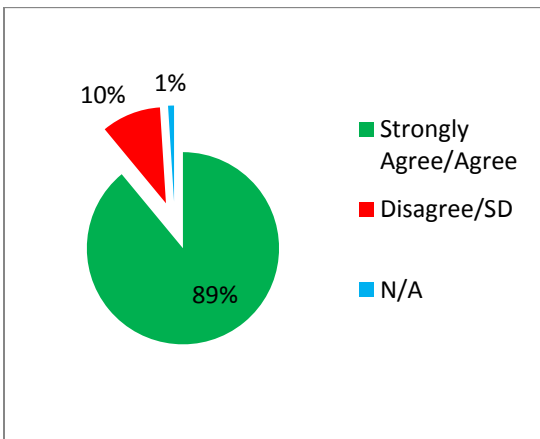
I feel welcome at the school.



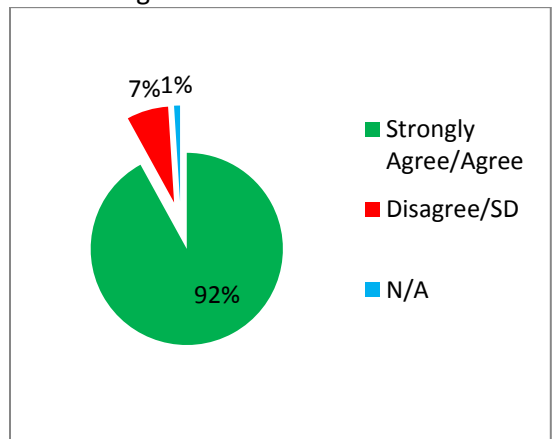
I feel the school values diversity of a child's background.



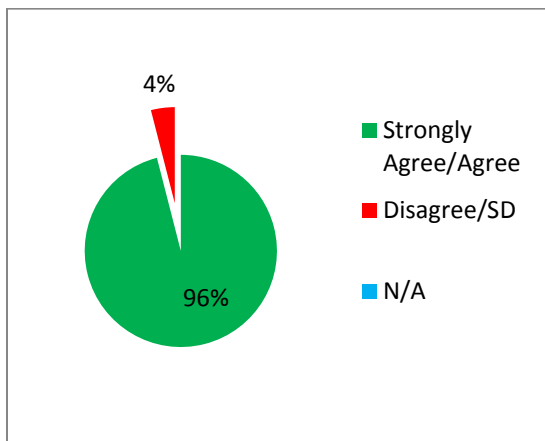
My child is treated with respect by other students.



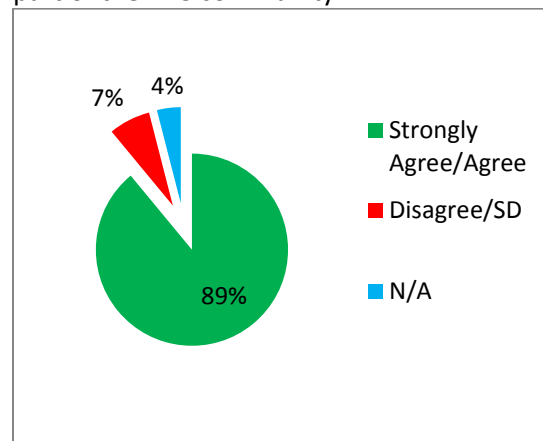
My child feels that the majority of his/her peers are treating each other with kindness.



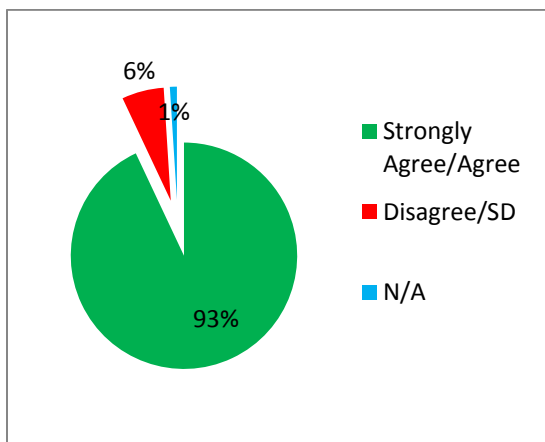
My child is treated with respect by staff.



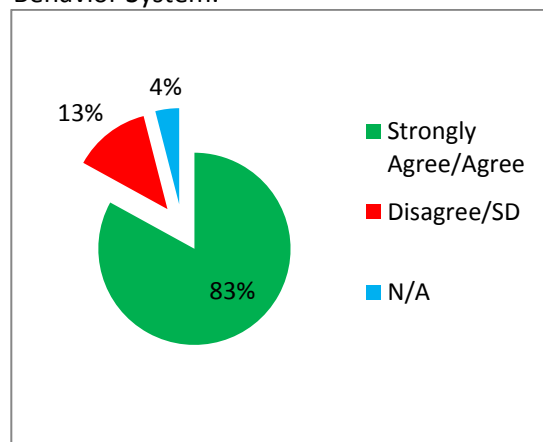
My child feels a sense of pride about being part of the HES community.

My child seems invested in the Pawsitive Behavior System.

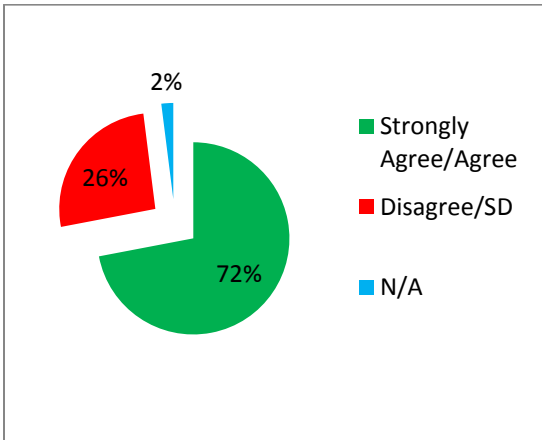

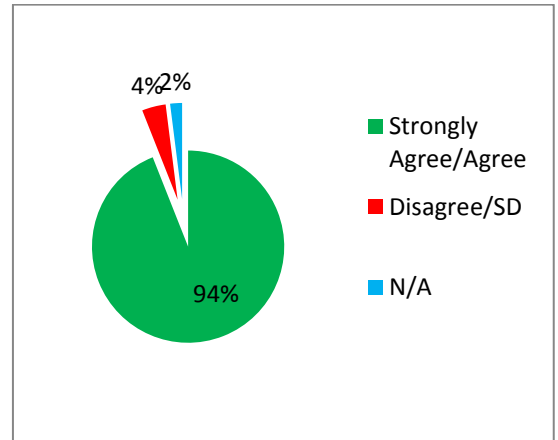

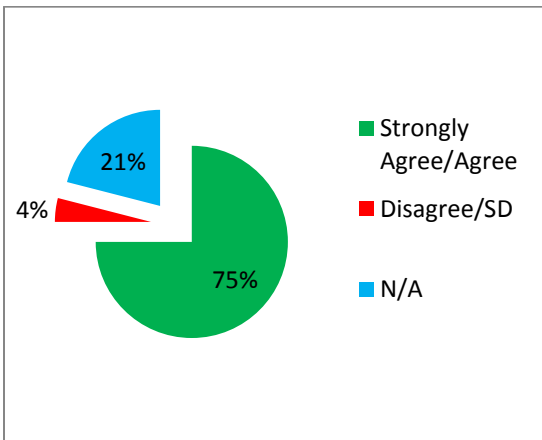
I feel there is adequate communication from school about information and events.



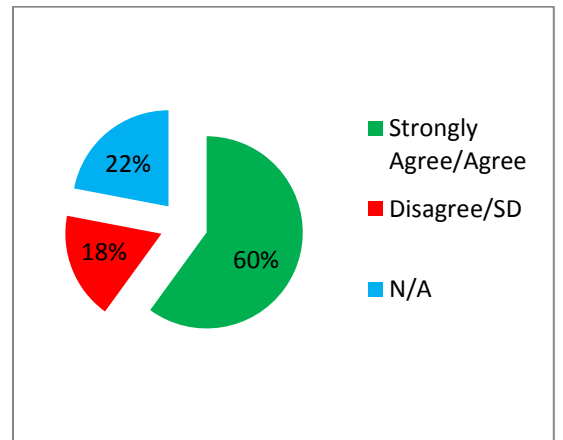
Teachers respond in a timely manner to my questions/concerns.



Administration responds in a timely manner to my questions/concerns.

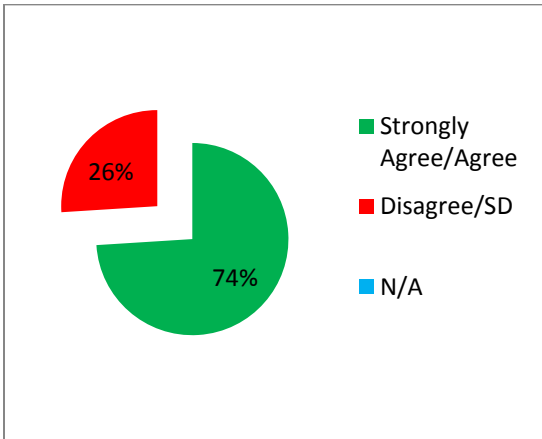

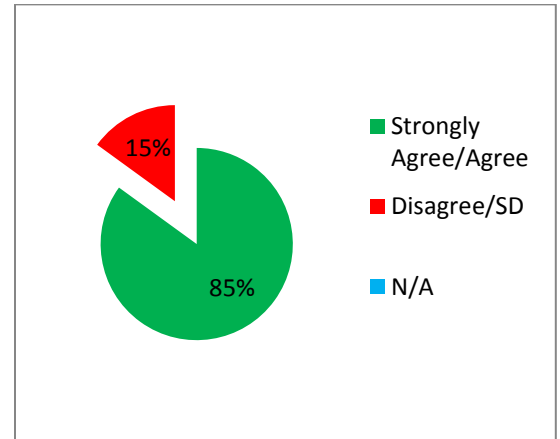


## 5. Please respond to the following statement about your child's academic progress and learning.

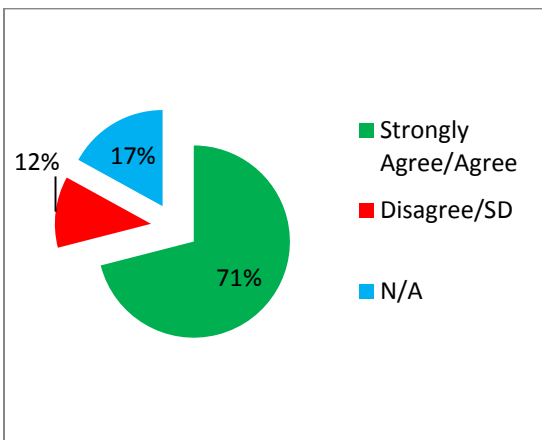
I feel like I have a sense of my child's academic progress throughout the year.



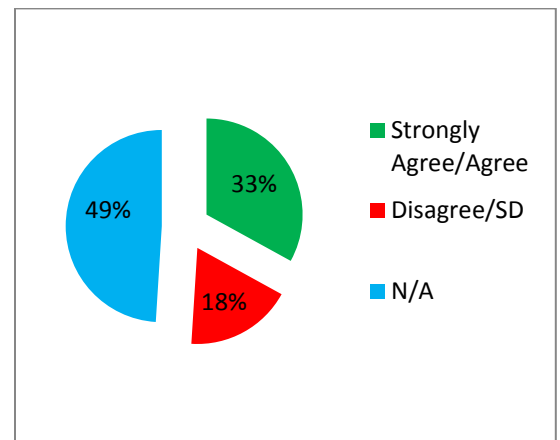
I am aware of the curriculum being taught at my child's grade level.



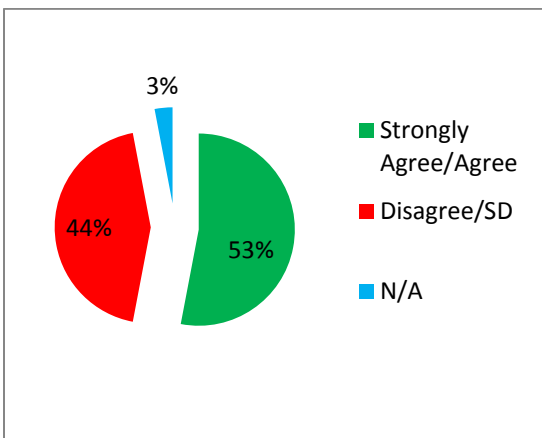
I feel there is adequate support for my child if he/she is having difficulty in an academic area.



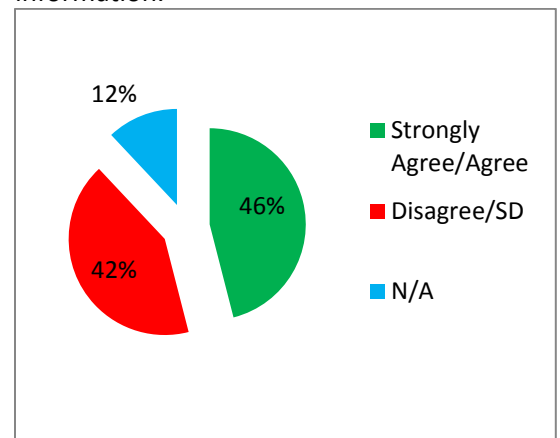
If my child receives math or reading intervention, I was provided enough information by the school to understand why.



I think receiving a report card twice a year is enough.

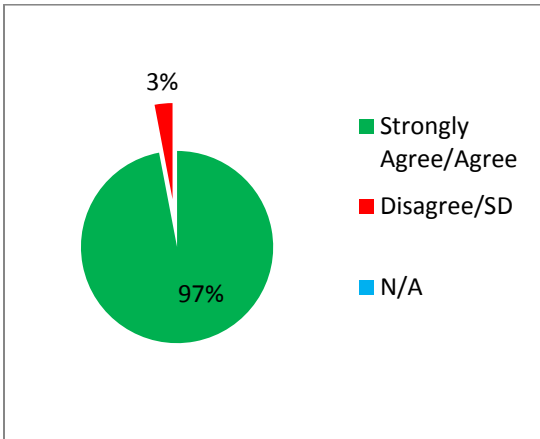


I think the current report card provides adequate information.

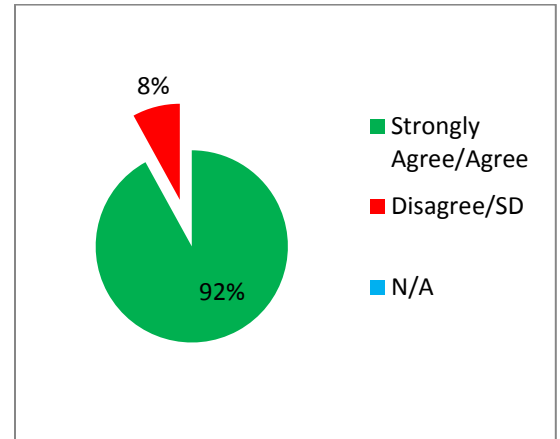


## 6. Please respond to the follow statements about school safety.

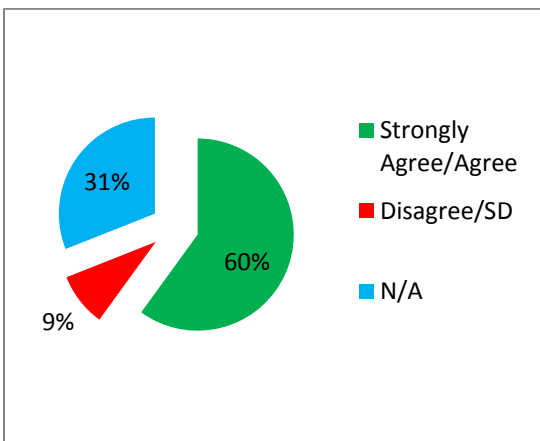
My child feels safe at school in general.



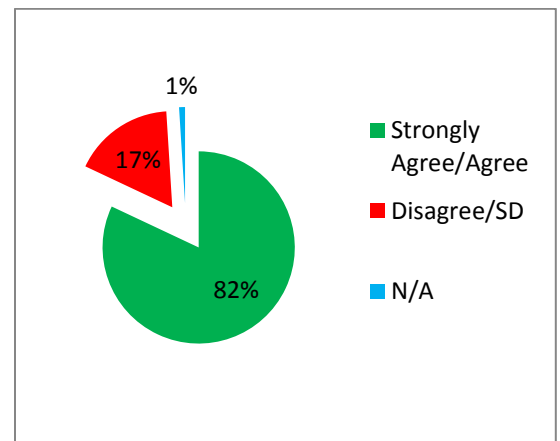
My child feels safe during unstructured times (recess/lunch/halls).



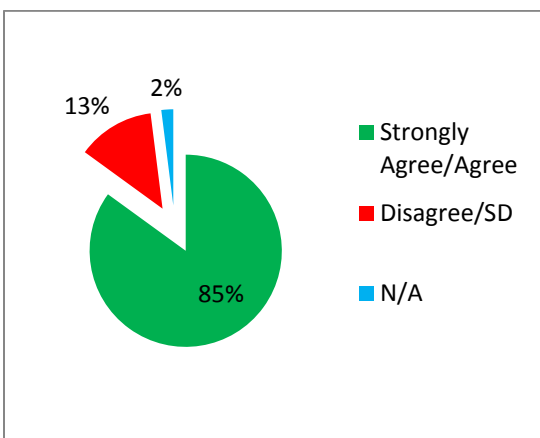
My child feels safe on the bus.



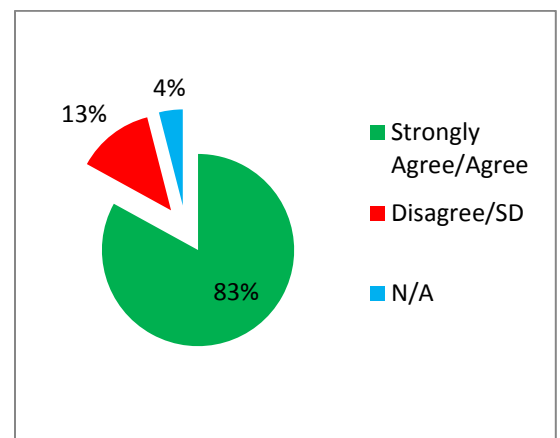
I am aware of the school's anti-bullying/social skills curriculum.
